INSTRUCTIONS FOR PRESENTATIONS TO THE BOARD BY PARENTS AND CITIZENS The Westlake Charter School ("School") welcomes your participation at the School's Board meetings. The purpose of a public meeting of the Board of Directors ("Board") is to conduct the affairs of the School in public. We are pleased that you are in attendance and hope that you will visit these meetings often. Your participation assures us of continuing community interest in our School. To assist you in the ease of speaking/participating in our meetings, the following guidelines are provided.

- 1. Agendas are available to all audience members at the door to the meeting.
- "Request to Speak" forms are available to all audience members who wish to speak
 on any agenda items or under the general category of "Public Comments." All
 comments shall be limited to three (3) minutes per person..
- 3. "Public Comments" is set aside for members of the audience to raise issues that are not specifically on the agenda. However, due to public meeting laws, the Board can only listen to your issue, not respond or take action. The Board may give direction to staff to respond to your concern or you may be offered the option of returning with a citizen--requested item.
- 4. With regard to items that are on the agenda, you may specify that agenda item on your request form and you will be given an opportunity to speak when the Board discusses that item.
- Members of the public may request that a topic related to school business be placed on a future agenda by making a request to the Board President. Once such an item is properly agendized and publicly noticed, the Board can respond, interact, and act upon the item.
- 6. In compliance with the Americans with Disabilities Act (ADA) and upon request, the Charter School may furnish reasonable auxiliary aids and services to qualified individuals with disabilities. Individuals who require appropriate alternative modification of the agenda in order to participate in Board meetings are invited to contact the Board President.

- A. Accept and approve Finance Committee's proposed policy #1016-01 Financial Reserves Policy-S. Burman
 - JW Economic restricted?
 - SK Authorizing district doesn't want anybody dipping into it as it can reflect badly on them.

 - HG I have a desire to take some of the fundraising pressure off of parents. I would like a committee to look into grants and corporate support.
 - KH Larger purpose such as DC trips
 - JW We are signaling that we want to do something more with fundraising.
 - JE Partnering with corporations to help our implementation of our wildly successful idea
 - HG Hoping to have non board members on the committees. Prevents burn out and grooms potential board members.

Staff responses included issues around management of them. Enforcement of any dress code is always an issue.5 negative responses

Paul Newton - Has heard from parents, policy is fiscally and environmentally irresponsible. Families have to buy two sets of clothes. Researched, students should hide who they are. I would like to see an optional uniform policy so people who like uniforms can still wear them.

- AC Have parents ever been formally surveyed or is it all just hearsay.
- HG Can we include it in the spring survey
- JC I've been on the board for many years and have never heard a parent complaint. There's something about being part of a culture, I understand individuality. My kids are proud to be an explorer, only a small part of that is the uniform. As an administrator
- SB Even if we abolish the uniform policy we'd still have to have a dress code and that would also stifle. I wore uniforms and loved it, I love it for my kids. It makes life much more easy.
- KH I remember the pressure of wearing fashion. I like that all kids can feel included regardless of finances. Takes social stigma out of it.
- AC The students do have their own way of expressing their personality. Spirit days add some opportunities to express themselves.
- EB Son told somebody he "attends a professional educational school". Appreciates it as an administrator as well.
- HG Works well for my child who has tactile
- JC Include a question in the spring parent survey. You can be anything you want to be you can't be everything you want. We are a school of choice, you get a better education here and if uniforms are a consideration then that's a personal choice.
- JE Where we put our time right now is on our kids, at other schools you spend a lot of time talking to kids about what they chose to wear that day. It's a manpower issue that would have to be worth the payoff.
- JC Lost learning time spent on addressing clothing issue
